However, the cities in India have been divided in three categories according to the status of the city. The IHMs are located in A and B category cities, have been given discretion of charging higher rate of tuition fee. The categorization of the cities and the discretion of charging increased tuition fee is as under.

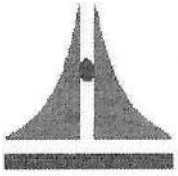

हाल के दिनों में, इस परिषद् को संबद्ध संस्थानों से स्नातकोत्तर डिप्लोमा, डिप्लोमा और क्राफ्ट पाठ्यक्रमों के लिए संस्थानों द्वारा निर्धारित शुल्क संरचना को प्रमाणित करने हेतु अनुरोध प्राप्त हुए हैं, ताकि राष्ट्रीय परिषद् के प्रमाणीकरण को संबंधित राज्य सरकारों के छात्रवृत्ति पोर्टल में अपलोड किया जा सके। इस संबंध में, इन पाठ्यक्रमों के लिए सभी संबद्ध संस्थानों द्वारा अपनाएं जाने वाले एकसमान शुल्क की मान्यता/निर्धारण के संबंध में, 14 मार्च 2022 को आयोजित अपनी 53वीं बैठक में परिषद् के अधिशासी मण्डल के समक्ष मामला रखा गया। तदनुसार, राष्ट्रीय परिषद् के अधिशासी मण्डल ने शैक्षणिक वर्ष 2022-23 से राष्ट्रीय परिषद् के तहत संबद्ध संस्थानों द्वारा चलाये जाने वाले स्नातकोत्तर डिप्लोमा, डिप्लोमा और क्राफ्ट पाठ्यक्रमों के लिए निम्नलिखित सामान्य शुल्क को मंजूरी दे दी है और इस परिषद् द्वारा अगली अधिसूचना तक मान्य होंगे:

प्रवेश शुल्क	1500 रुपये (उपरोक्त सभी प्रोग्रामों के लिए एकसमान)
नामांकन शुल्क (एनसीएचएम घटक)	1½ वर्ष के प्रोग्राम के लिए 900 रुपये) 1 वर्ष के प्रोग्राम के लिए 600 रुपये
परीक्षा शुल्क (50% एनसीएचएम घटक)	2500 रुपये (उपरोक्त सभी प्रोग्रामों के लिए एकसमान)

शिक्षा शुल्क	निम्नलिखित शुल्क केवल राष्ट्रीय परिषद् द्वारा अधिकतम शुल्क है जो सभी संबद्ध संस्थानों के लिए सामान्य है और किसी भी संस्थान को अधिकतम शुल्क से अधिक शुल्क नहीं लेना होगा: • PGDDHFS, DFP, DBC एवं CCCFP प्रोग्रामों के लिए प्रति सेमेस्टर 35000 रुपये (प्रति वर्ष 70,000 रुपये) • अन्य प्रोग्रामों के लिए 25000 रुपये प्रति सेमेस्टर (प्रति वर्ष 50,000 रुपये)

संस्थान, सीमित शुल्क सीमा में अपने संबंधित बोर्डों के अनुमोदन से केवल शिक्षण शुल्क घटक निर्धारित करेंगे। अन्य गतिविधियाँ हेतु शुल्क के मामले में, यदि कोई हो, संस्थान अपने अध्ययन के दौरान छात्रों के लिए नियोजित गतिविधियों के अनुसार गतिविधि शुल्क ले सकता है। उपरोक्त सामान्य शुल्क संरचना शैक्षणिक वर्ष 2022-23 से प्रभावी होगी। हालांकि, औद्योगिक प्रशिक्षण के दौरान संस्थान छात्रों से कोई शुल्क नहीं लेगा।

Sub: Recognition of fee structure for PG Diploma/Diploma/Craft Courses run by the affiliated Institutes under affiliation with NCHMCT.


Sir/Madam,

In recent past, this Council has received requests from affiliated Institutes for certifying the fee structure fixed by the Institutes for PG Diploma, Diploma & Craft Courses that are running by them, so that the certification of NCHM can be uploaded in the scholarship portals of respective State Governments. In this connection, towards recognition/fixing of uniform fee to be followed by all affiliated Institutes for these courses, the matter has been put up before the Council's BOG in its 53rd meeting held on 14th March 2022. Accordingly, the BOG of NCHMCT has approved the following common fee for PG Diploma, Diploma & Craft Courses to be charged by the affiliated Institutes under NCHMCT from 2022-23 academic year onwards and will be valid till further notification by this Council:

Admission Fee	Rs.1500 (common for all the above programs)
Enrolment Fee (NCHM component)	Rs.900 for 1½ year program Rs.600 for 1 year program
Exam Fee (50% NCHM component)	Rs.2500 (common for all the above programs)
Caution Money	• Rs.3000 for PGDDHFS, DFP, DBC & CCCFP programs • Rs.2500 for other programs
Tuition Fee	Following fee is maximum capping by NCHM only which is common for all affiliated Institutes and no Institute should charge more than the capped fee: • Rs.35,000 per Semester (Rs.70,000 per year) for PGDDHFS, DFP, DBC & CCCFP programs • Rs.25,000 per Semester (Rs.50,000 per year) for other programs

The Institutes will fix only in tuition fee component with the approval of their respective Boards within the limit of capped fee. In case of fee for other activities, if any, the Institute can charge activity fee according to the activities planned for the students during their studies. The above common fee structure will be effective from 2022-23 academic year. However, during industrial training, the Institutes will not charge any fee from the students.
